4.0 PostalOne! System

4.1 Omnibus Price Change Price Change

The *PostalOne!* System will be updated to support new pricing structures and rates for domestic and international mailings, effective July 13, 2025. To accommodate the pricing and structural changes the US Postal Service will update domestic and international postage statements, permit fees, Business Reply Mail (BRM), and Merchandise Return Service (MRS) to reflect the prices on the July 2025 Notice 123, effective July 13, 2025. REQ 25268, REQ 25273, REQ 25274

4.2 Electronic Verification System (eVS) Retirement

The Postal Service will discontinue use of the Electronic Verification System (eVS) and require the use of USPS Ship for the acceptance and payment of all commercial domestic and international parcel mailings. All systems interfacing with eVS will turn off their feed on July 31, 2025 and all transactions will be sent to USPS Ship. Technical support for eVS will continue until (date TBD).

All reporting systems currently supporting reports for eVS will be maintained until account data can be migrated to USPS Ship (date TBD). Reports will remain available under current retention periods. Refunds, adjustments, and

reconciliation processes will be maintained until eVS retirement or USPS Ship migration.

4.2.1 Discontinuation of System Interface with eVS

All systems interfacing with eVS will turn off their feed on July 31, 2025 and all transactions will be sent to USPS Ship. Technical support for eVS will continue until (date TBD).

4.2.2 eVS Reporting Support

All reporting systems currently supporting reports for eVS will be maintained until account data can be migrated to USPS Ship (date TBD). Reports will remain available under current retention periods.

4.2.3 Publications, Communications and Training Support

Publications currently referencing eVS will be updated to USPS Ship by (date TBD).

Internal and external communications will be created for employees and customers to ensure that they understand what is involved in the migration to USPS Ship and retirement of eVS.

4.3 Postage Statement Enhancements

The RPW Mail category codes will be enhanced to improve reporting on discounts, incentives, and promotions in both the TRAN and PLINE files, providing users with clear visibility into negative revenue and volume data at the product rate-cell level.

4.4 Eliminate Marketing Mail Commercial & Nonprofit Automation Basic CR Letters

The US Postal Service is considering eliminating Marketing Mail commercial and nonprofit Automation Basic CR letter rates.

4.7 Alaska Bypass Nomenclature Update

The Alaska Bypass Nomenclature will be updated to clarify shipping terms and improve accuracy for mailers. All references to "Zone 1 & 2" in publications and price tables pertaining to Alaska Bypass shipping will be eliminated, as the service only supports Zone 1 volume. This change addresses a common misconception among mailers who might be misled by incorrect terminology. Additionally, the Domestic Mail Manual (DMM) will be revised to reflect these updates, including language adjustments such as replacing "prices are" with "the price is" and removing unnecessary references to zones. The changes will impact the Commercial portion of the Market Dominant product Alaska Bypass and are not applicable to the Competitive product Limited Overland Route (LOR).

4.8 Nonstandard Fee Overhaul

The US Postal Service is considering updating the rules for package Nonstandard Fee structures. These fees are applicable to Priority Mail Express, Priority Mail, USPS Ground Advantage, USPS Connect Local and Parcel Select packages based on the following criteria: The Nonstandard Fee is currently charged for packages meeting the following criteria:

- a) Length greater than 22 inches but less than or equal to 30 inches.
- b) Length greater than 30 inches.
- c) Cubic volume greater than 2 cubic ft.

The Nonstandard Fee will now also include the Package Characteristics as a criterion:

- a) Cylindrical tubes or rolls.
- b) A can, or wooden or metal box.
- c) A parcel containing more than 24 ounces of liquid in glass containers, or 1 gallon or more of liquid in metal or plastic containers (see DMM 601.3.4).
- d) Other (e.g., parcels prepared under DMM sections 601.3.0 and DMM 601.4.0. with contents that may cause the parcel to roll or not maintain the integrity of the packaging during processing)

The assessment for packages may result in following Nonstandard Fees being charged:

- a) Nonstandard Fee for one of two Length criteria (noted above)
- b) Nonstandard Fee for Volume criteria (noted above)
- c) Nonstandard Fee for Package Characteristics criteria (noted above)
- d) Nonstandard Fee Length + Volume
- e) Nonstandard Fee Package Characteristics + Volume

Note: Only the greater of the two: Length vs. Package Characteristics may be assessed per package. The Dimension Noncompliance Fee will reflect the changes to the Nonstandard Fee criteria. This update will include identification of Package Characteristics in the Manifest.

4.11 Combine Plus One and DML Products

The US Postal Service is considering merging Detached Marketing Labels (DML) and Plus One to enhance the value of this product for mailers and simplify the postal product offering. 4.20 Add 5D/Direct Container and SCF-Pallet discounts to Marketing Mail Heavy Printed Matter
